## New Tax Bracket over \$100 Million

Currently, the top income tax bracket for a married couple filing jointly in the U.S. is 37 percent on all ordinary income over \$731,201, meaning that anyone making above that amount is taxed at the same rate, whether they make \$750,000 a year or \$5 million a year. Some have argued that households making \$731,201 a year are not realistically in the same income bracket as those making several million a year, and have proposed adding additional brackets for those making over \$1 million. If several new brackets were created for ordinary income, with the highest bracket on income over \$100 million, what is the highest marginal tax rate you would support on those making over \$100 million a year?

This survey is based on 800 interviews conducted by YouGov on the internet of U.S. adults who identify as having assets excluding their home of over 1 million USD. The sample was weighted according to gender, age, race/ethnicity, education, and U.S. Census region based on publicly available data on the wealthy from the Federal Reserve Bank's Survey of Consumer Finances 2022. The weights range from 0.59 to 2.82 with a mean of 1 and a standard deviation of 0.25.

The margin of error (a 95% confidence interval) for a sample percentage  $p$  based upon the subsetting sample is approximately 3.6%. It is calculated using the formula:

$$\hat{p} \pm 100 \times \sqrt{\frac{1 + CV^2}{n}}$$

where  $CV$  is the coefficient of variation of the sample weights and  $n$  is the sample size used to compute the proportion. This is a measure of sampling error (the average of all estimates obtained using the same sample selection and weighting procedures repeatedly). The sample estimate should differ from its expected value by less than margin of error in 95 percent of all samples. It does not reflect non-sampling errors, including potential selection bias in panel participation or in response to a particular survey.
